First week in April 2020, staff gathers with residents at CP Bayville. The week prior 37 of the 46 individuals living at this home tested positive for COVID-19.

In an effort to provide the safest environment and lower exposure to patients with COVID-19, areas at the CP Nassau main facility were established, sanitized and set up with hospital beds and medical equipment. Dedicated nurses and direct support personnel worked with the individuals in this "Safe House" and devoted long hours and compassionate care was instrumental in their well-being.

On April 8, 2020, the New York Times featured a story about CP Bayville on its front cover that continued as a full page inside. This article would generate a flood of encouraging correspondence from all over the country and world. Financial support, community involvement and media attention came as a result as well.

The Agency invested over \$200,000 in professional sanitizing and disinfecting equipment to maintain the safety of all in the main facility, every home, every Day Program site and at CP Bayville.

Our nursing and medical assistants at CP Nassau, CP Bayville and all small residences were recognized in special way during National Nurses week. These dedicated and skilled staffers truly saved lives through their efforts and their courage and commitment was continuously recognized by all including administration, families, and co-workers.

This thank you banner expressed appreciation to the Bayville community who were wonderful in their support. Groups all over Nassau County and beyond came forward and offered amazing assistance, and their kindness and generosity got us through and will never be forgotten.

The Children's Learning Center staff, students and families are to be commended for their innovation and resilience during the Pandemic. The graduation for upper school students was held in "drive-by" format with strict social distancing protocols in place. Despite this, everyone in attendance was joyous in celebrating the accomplishments of our students and expressing thanks to the CLC faculty and staff whose efforts made these accomplishments possible.



The grant will also fund new disinfecting systems, machines, cleansers and, other equipment needed for new protocols established to effectively fight the COVID-19 virus and ensure the safety of patients, their families, staff and visitors.

The year 2020 started with the need to solve a cyber virus and ended with the onslaught of the Pandemic and the Covid-19 virus.

While the cyber attack which invaded CP Nassau's IT structure at the end of 2019 was largely resolved in early 2020, the solutions required substantial changes. Led by Larry Davies and fueled by outside consultants, analysis showed a need to alter our application of resources. We now utilize a large IT vendor to provide, largely remote, state of the art technology to keep us safe and fluid in managing our businesses.

In March of 2020, the world inside and outside CP Nassau was turned upside down. Residents and staff in our homes were testing positive for Covid-19, PPEs were scarce and sometimes unavailable, the School, Clinic and Day Programs were ordered closed by the Governor and our world entered frightening uncharted waters.

The services at CP Nassau / CP Bayville did not end, however, with the Governor's mandate, as our residential programs were confronted with the challenge of operating safely, staffing appropriately, and ameliorating the fears of our residents, their families and our heroic staff.

The story is well known by now, people got sick, individuals died; devastating experiences for all. These were clearly very challenging times that required us all to come together and face obstacles that had never existed before.

At this writing, we hope that we have come through the worst of the pandemic. We recognize our staff, direct service providers, nurses, managers, clinicians, the maintenance staff and all of our other support staff. Our families have been overwhelmingly supportive of our staff and have frequently shown their appreciation for staff's efforts by delivering food and PPEs throughout this crisis. Our community support has also been remarkable as numerous new and previously known friends have recognized the value of the work accomplished by our staff. We have been overwhelmed with their kindness. Our Agency's work has been validated over and over again.

We too recognize the lives that have been saved and that heroes surround us. We are aware of the need to continue our fight with Albany to get our fair share of reimbursement for our OPWDD programs, school tuition and clinical support.

Thank you all for what you have accomplished in these extraordinary times.

You have made a difference for thousands of people.

Participants and staff from all programs were able to meet on Zoom and hold



When the "Safe House" was born out of the need to have some of the individuals residing at Bayville move to a different setting, day program staff turned the multi-purpose room and classrooms at the Center into bedrooms; provided care and support for the guys around the clock and made it a home away from home! Staff made fun Tick Tok videos, assisted the guys with staying in contact with their families, Cafeteria staff cooked their meals, Transportation

staff transported whomever and whatever they were asked to, and last but not least, our truly wonderful families donated meals for our staff! We certainly learned how truly amazing the ADS staff and families really are!





The long time Coordinator of Wantagh Day/Program Without Walls, Mary Hodge, left us for a new and exciting opportunity however is still the Head Coach of the CP Nassau Thunderbolts. Mary has been replaced by Jasmine Harris who, not surprisingly, has been quickly and wonderfully well-received.

The Children's Learning Center (CLC)

On March 16th schools throughout Nassau county were closed by executive order to halt the spread of coronavirus. What was thought would be a 2 week closure turned out to be a six month closure of CLC to in-person learning.

A brand-new model of learning, remote instruction, was implemented through the roll out of G-Suite for Education

within CLC. G-Suite allowed for video instruction, virtual classrooms, remote therapy, staff video meetings, coordination of student learning through group chatrooms, distribution of

homework assignments, and other day to day operations of CLC that could no longer take place in-person.

Transitioning to this new model was not easy, presenting a number of issues to students, staff, and parents. Learning and implementing a whole new model of instruction in such a short time was difficult.

Kevin Loughlin, CLC Principal, reports that CLC staff, teachers, clinicians, managers, secretaries, nurses, and classroom staff all adapted quickly and rose to the challenge.

Remote learning and G-Suite have become an integral part of CLC. CLC offered, in the summer of 2020, in-person services for students whose parents chose to send their children in. It was only

for a half-day, once a week, but it allowed much needed services, including therapy, to be provided. In September CLC opened up with a hybrid model, two days of in school learning and two days of remote learning. In November preschool went to 5 full days of in-school learning for parents who chose to send their children in and maintained remote learning for those who did not.

Residential and CP Bayville

The year 2020 started out like any other for the individuals who reside in Bayville and CP Nassau's residential homes. The residents rang in the New Year and enjoyed activities in the community, visits with family, and attending Day Program. That all began to change in the middle of March – families could no longer visit, Day Program closed, and the residents could not go out in the community.



By the end of March, our lives changed forever. COVID-19 began to hit our homes and residents fell ill. Quarantines were put in place. Bayville was hit particularly hard. Days previously filled with games and activities, were now filled with temperature checks, PPE, and disinfecting schedules. Through the spring of 2020, residents and staff persevered. Staff at every level in the Residential program and Bayville stepped up like never before.



Many staff chose to stay at their work locations and provide the care, support, and reassurance that our residents desperately needed. The communities surrounding our homes warmed our hearts and lifted our spirits with an outpouring of love; sending meals, snacks, masks and more for the staff. Letters, cards and pictures were left almost every day with words of encouragement for staff and get well wishes for the residents. The Bayville community was especially supportive and caring throughout.

By the end of Spring CP Bayville and Residential had lost 8 beloved residents. To all that passed we say: "Your presence we miss, your memory we treasure, loving you always, forgetting you never".









Human Resources/Payroll/Information Technology

The Human Resource and Payroll staff are responsible for recruiting and hiring employees, managing employee benefits, including medical, dental, disability, life, and pension. In addition, they are responsible for managing and monitoring employee compensation for over 800 employees working in more than 50 different departments in 20 different locations.

COVID-19 created a myriad of challenges for our Agency, including the staff in Human Resources and Information Technology. When the pandemic began, we decided to isolate the Human Resources and Payroll staff and to work remotely as much as possible. It's one thing to delay the mail for a day. It's quite another to delay payroll. Due to the hard work and dedication of the payroll staff, a pay date was never missed throughout the pandemic. The decision made years earlier, to move to a web-based Human Resources and Payroll software solution greatly facilitated our move to remote work. Nonetheless, much of the work done with our managers and staff is done face-to-face. When remote work became the standard, the Human Resources and Payroll staff modified their paperwork and their procedures to meet this need.

Each year we talk about the never-ending regulations that Human Resources and Payroll must comply with. The past year was no different, with COVID-19 Sick Leave being added to the list. Like countless others in our Agency, the Human Resources and Payroll staff rose to the occasion. Throughout the year, these staff were able to meet the needs of the Agency without skipping a beat.

On the Information Technology side, our computer networks continue to evolve in an effort to add resiliency, reliability and flexibility to our Information Technology services. In 2020, the Agency changed our model of providing support and maintenance to our computer network and computer users by hiring a managed services provider (MSP), Consolidated Technologies Inc. (CTI). If the name CTI sounds familiar, that is because they were the company that came to our rescue and rebuilt our network after the MedusaLocker Ransomware virus infected every single computer and server in our Agency.

The decision to move to an MSP is consistent with our strategic plan to move our business-critical software systems from the IT office to the cloud. Previous efforts in that regard made the transition to remote work much easier than it might have been in prior years.

In 2017, we added Google's G-Suite for Education to the educational resources available in the Children's Learning Center (CLC). That decision greatly enhanced the ability of our CLC staff to respond to the pandemic. Google's G-Suite provided the management and staff in CLC all of the tools they needed to transition from in-person to remote learning. In 2019, we upgraded the hardware and services that provide secure VPN connections between the Center, our residences, and our Oceanside Day Habilitation program. The improved reliability of these systems has given staff working in our remote locations reliable access to our network resources at a time when they were greatly needed.

Finally, when the pandemic arrived, we were able to reach out to CTI for a remote access solution to individual users in our Agency. In a matter of weeks, CTI was able to develop a secure, remote access solution that allowed staff access to their office computers from home. This was especially valuable to our Finance staff who must have access to their office computers and our network resources in order to do their work.

Development

Though Covid deemed it necessary to cancel many of our events, we were able to hold our 5K Run virtually, host virtual Bingo events, and hold raffles as well. We are incredibly grateful for all our Committee members, constituents and friends who continued to support, donate, and remember us during these times. We received a great amount of support from the community with financial donations along with offers of meals catered and delivered for staff, donations of masks, PPE and other supplies and shared time and talent from a variety of guest speakers who participated on Zoom sessions with program participants. The Agency also benefited from a burst of media coverage that presented an opportunity to share our story, starting with a front page article in the New York Times and then appearances by our Executive Director on broadcast and print media.

CP Nassau was honored with the Lifetime Achievement Award and \$5,000 donation from the Imagine Awards program.

Fortunoff Treatment & Rehabilitation Center (FTRC)

In 2020, the Article 28/16 clinic provided slightly more than 15,000 patient visits. This number reflects a reduction in service delivery of approximately 30% as compared to prior years due to the COVID-19 pandemic. This pandemic presented challenges unlike anything we've faced in our medical clinic:

Primary Medical Care Visits: 1,959

Cardiology, GI, Physiatry, Optometry, Podiatry: 610

Dental: 381

Speech Therapy, Audiology: 1,951

Occupational Therapy/Seating: 3,281


Physical Therapy: 4,023 Mental Health: 2,928

2020 has been a unique year for healthcare. Like most healthcare facilities, CP Nassau needed to adapt to an



ever-changing patient engagement and adjust the delivery of healthcare services during the COVID-19 Pandemic. In order to reduce the need to provide in-person care so that we could minimize risks to patients and healthcare providers, we implemented telehealth services and virtual services whenever appropriate and possible. Telehealth technology, which had been only emerging prior to COVID-19, became a saving grace for patients who needed continuity in their chronic care management.

Smartphone selfies and images became an important supplement and powerful diagnostic tool for our medical providers. Through the use of smartphone images, our providers were able to address and manage important problems related to skin lesions, wounds, infections, medications while reducing the need for inpatient visits. Our medical and clinical staff





The QA Department served as the Agency's initial point of contact with the NYS Department of Health, the NYS Justice Center and OPWDD with the reporting, tracking and processing of all COVID-19 events, affecting both the workforce and service recipients.

The QA Department worked with the programs to ensure staff awareness and compliance with all COVID-19 mandated precautions and assisted with the development of COVID-19 policies for Residential and Adult Day Services

The QA staff assisted with the screening of perspective employees, in response to the staffing needs in the residences, assisted with the pick-up and delivery of PPE and/or oxygen supplies to the Bayville residence.

Traumatic Brain Injury Program (TBI)

TBI program staff moved to remote work and contact with participants occurred via phone or video conferencing.

The department sadly had to close our day program Cafe Connections due to the Pandemic.

Two participants passed away during the lockdown period of Covid.

TBI staff worked very diligently to ensure our participants' safety, placing weekly check-in calls, purchasing masks, delivering grocery items and medication as needed and sponsored a catered lunch for our frontline workers at the Roosevelt Campus

Finance

Nassau Cerebral Palsy Association and its subsidiaries, including Cerebral Palsy Association of Nassau County, Inc. (CP Nassau), CP Bayville and Rehab Solutions, Inc., showed a combined deficit of \$3,653,136. This was comprised of deficits for CP Nassau (\$3,134,984), Rehab Solutions (\$315) and for CP Bayville of (\$517,837).


The losses realized during 2020 were due almost exclusively to the COVID pandemic. We certainly anticipate improvement during 2021.


OPWDD and SED rates increased during 2020 primarily due to Be Fair To Direct Care initiative and Minimum Wage.
